For the year ended12/31/2015, the PRA had \$13,500 in income and \$16,600 in expenses resulting in a cash decrease of \$3,100. Major expenses were for the Newsletter, administration, and subsidies for the semiannual lunches. Placing the results in perspective, the PRA had an \$8,200surplus for the year ended December 31, 2014 resulting in a net two year surplus of \$5,100. Our cash balance entering was a strong \$28,000.

4. Audit Report-Richard Rosenblatt

The books have been examined and found to be in order.

5. Board Members Completing Their Terms-Edvie Johnson

There are five current board members whose three year terms are expiring this month. Arthur Aznavorian, Elizabeth Foote, George Murray, Scott Osler, Richard Rosenblatt. Incumbents are eligible to run for another three year term and have agreed to do so. A motion was made and seconded to elect these members, and it was approved by voice vote.

One new member Mary McCann has agreed to fill a vacancy in the Board and was voted in, approved by voice vote also.
