

## PRA Board Nominations for May Meeting

The PRA Board of Directors has 18 positions. Directors are elected for three year terms and the terms are staggered, so that six Directors are elected each year. A Director may be elected three times and serve a total of nine years. Directors are sometimes appointed to fill the remaining years of an elected Director who leaves the Board before their term expires, and those Directors are still eligible to be elected three times — serving slightly more than a total of nine years.

This year, two Directors finish their nine years of service: Steve Berry, and Doris Harriman.

Four current Directors have agreed to run for re-election, and the Board is nominating two new members to fill the remaining seats.

**Joanne Bellofatto (New Nominee):** Joined Polaroid in 1977 served in the Camera Division in secretarial and planning positions. Left the planning department in 2004.

**Elizabeth Foote (New Nominee):** Joined Polaroid part-time 1977-1986 serving in Corporate Training and Development; became full-time member in 1986 serving in Human Resources, Manufacturing and Information Technology; resigned in 2001.

**Lucille Kelley (Incumbent):** Joined Polaroid in 1965 and served in engineering positions in the Film Division-Quality Systems, Manufacturing Information and Control Systems, Color Component Release Systems, and in the Battery Division — involved with component battery material release for assembly. Took the early retirement program in 1982.

**George Murray (Incumbent):** Joined Polaroid in 1970 in the SX-70 Development Team in W4. Held assignments in Film Manufacturing, International Quality Management, and Corporate Quality, retiring in 1996.

**Scott Osler (Incumbent):** Joined Polaroid in 1976 as a member of Finance Division. During the next 32 years, he served in Waltham at both the Reservoir and Main Street sites, in Cambridge at both 640 Memorial Drive and Tech Square, Norwood, New Bedford's NB6 building, and Bedford. He retired from Polaroid in 2007 when film production in Waltham ceased.

**E. Richard Rosenblatt (Incumbent):** Started at Polaroid in 1965, serving in QC, Research, the Rover/Tiger project, SX-70 sheet coating start-up and Chemical purchasing, retiring in 1996.

# **Proposed Amendments To the PRA Constitution**

At the May 2013 Luncheon and Business Meeting, PRA members will be asked to vote on two minor amendments to the PRA Constitution. These proposed amendments resulted from conversations among PRA Board members - and comments from PRA members - about how to encourage more ex-Polaroid employees to consider joining the PRA.

The first change proposed is a one word change to Article III, Section 1 (Membership) to clarify that PRA membership is open to all ex-Polaroid employees with seniority dates prior to July 2002, and their spouses. The wording change is as follows:

"Section 1. Regular Membership in the Association is limited to retired (strike) previous (add) Polaroid employees with Polaroid seniority dates prior to July, 2002, and their spouses."

The second amendment proposed is to strike Article III, Section 2, which reads:

"Associate membership in the Association is available to full-time Polaroid employees over the age of fifty (50) years with at least fifteen (15) years of continuous service and with Polaroid seniority dates prior to July, 2002."

This article is no longer needed, since there are no full-time employees.

A majority vote of the membership in attendance is required for adoption of these changes.

**Bob Harris writes...** I worked as a Department Manager in New Bedford, Senior Manager in W4, Operations VP of PGI and finally on the Joshua Project. I resigned in January 1991 and joined Konica Manufacturing USA (KMU) in Greensboro, NC as the senior American executive.

In 1993 I was named President of KMU and continued in that role after the merger that formed Konica

Minolta. I had to announce to the employees in January 2006 that we were shutting down the company as Konica Minolta had decided to exit the consumer imaging business. We would continue coating until the end of December 2006 and then slit and ship for several months after that.

In September 2006 I got a call from Marc Finneran of ZINK Imaging asking if we could coat their product. I had been on the interview team that hired Marc into W4. The answer was yes but I also told him that we were closing the business at the end of the year. Later in November I was travelling to Europe and while at O'Hare in Chicago got another call from Marc telling me that ZINK might be interested in buying the plant.

That day we spent a couple of hours on a conference call with the ZINK management team before I left the states. I later arranged with my staff to schedule a visit by Marc and others to tour the facility.

We quickly started trials with ZINK providing the chemicals and base and Konica Minolta covering the labor, energy, etc.

After several months of trials ZINK was confident that the plant could make their product and decided to buy the assets in early July 2007.

A group of 60 of us ended our employment with Konica Minolta on a Friday and started working for ZINK the following Monday. I stayed with ZINK as a Senior VP until I retired in April 2012.



# Time Zero: The Last year of Polaroid Film

### An up and coming documentary that covers the Death and Rebirth of Polaroid Film

Time Zero: The Last year of Polaroid Film, made by an enthusiastic Polaroid user, Grant Hamilton who has captured through his documentary the death, the unexpected yet brilliant rebirth of Polaroid film and the people who our avid instant film lovers.

In 2008, Polaroid sadly decided to discontinue the beloved instant film. Yet a lot of people still liked taking Polaroid photos and found the camera that produced instant prints to be magical, something that digital couldn't match. One fan who missed Polaroid film so much made his attempt to buy the Polaroid factory in the Netherlands with the intention to restart production.

He entitled the rebirth of instant film "The Impossible Project". Thanks to The Impossible Project, they have managed to gather old fans as well as a new generation of fans that don't recall the heyday of Polaroid.

The film premiered the 28th of April 2012 at The Independent Film Festival at the Somerville Theatre in Somerville, Mass, which is a perfect location for a documentary based on Polaroid film as the theatre is only three miles away from Polaroid's former head-quarters.

We were able to get an interview with Hamilton, here is what he had to say about the documentary:

Film's not Dead: Your obviously a huge fan of Polaroid film, could you possibly tell us how you discovered it?

**Grant Hamilton:** In 2006, I had been using a DSLR but thought that the images were kind of sterile. I joined flickr around that time and discovered that some people were using Polaroid instant film and getting the kind of character I wanted in my photos. I bought an SX-70 on eBay shortly thereafter and started experimenting. I really liked the square format and the painterly quality of the images.

Film's not Dead: What is it about the Polaroid that attracts you to use it and do you solely shoot on it?

Grant Hamilton: I use other cameras but the Polaroids are my favorites. Besides the reasons I mentioned above, I like that the Polaroid creates a photo and not an image. That is unique in photography. There is no negative—no making multiple prints—if you get a good one, it's that much more valuable because it is the only one.

Film's not Dead: Where did the idea come from to make a documentary about the death and rebirth of the instant film?

Grant Hamilton: After Polaroid announced that they were stopping production of instant film, I noticed that most other people weren't very bothered by the news. Whether or not you are a photographer, I thought that instant photography was an integral part of the fabric of the culture of the 20th century and deserved more respect than that. My first idea for the movie was to make a long eulogy but after the Impossible team was formed, the story took a turn as I realized that I might have a happy ending after all.

Film's not Dead: How many photographers in total have you managed to get into your documentary?

**Grant Hamilton:** I don't have an exact number handy but there are about fifty photographers whose photos appear in the movie and about fifteen photographers appear on camera.

Film's not Dead: Also, how long did it take you to make this documentary?

**Grant Hamilton:** I wasn't able to devote 100% of my time to it so it ended up taking about 4 years.

Film's not Dead: What is it like for you working with the Impossible film now?

**Grant Hamilton:** I absolutely love the new PX70 and PX680 films. I think they look a lot like Time Zero film but are less blue.

Film's not Dead: What do you hope to achieve from this documentary?

Grant Hamilton: World domination. I also hope that for the people who aren't avid instant photographers, they realize the importance of having a print. All the digital images on our computers are temporary. Whether due to data rot, changing technology, abandoned websites or computer crashes, these pictures won't be here in fifty years. In contrast, I still have photographs of my grandfather as a child. For the people who are fans of Impossible and Polaroid, I hope to show them how close they were to losing their medium and how that story unfolded.

Film's not Dead: What do you think Edwin Land

#### would say if he saw this documentary?

**Grant Hamilton:** I think he'd wonder what the hell happened to his company.

Film's not Dead: From the look at your trailer it is apparent that there is a large majority who still demand to use instant film, the future looks bright, what do you believe the future is for instant film?

Grant Hamilton: I think that the future is very bright. People are starting to realize that they don't have to abandon the analog technologies that preceded digital ones. They can use both. Most Impossible customers are new customers who are just starting with instant film. As they continue to refine their films, I think the market will only get bigger. It's not just film either. Vinyl record sales are increasing for the last five years. People still want tangible books despite the advent of e-readers. So, I think we are going to have more choice and a richer experience.

## Polaroid Memories: Buildings we worked in

#### **640 MEMORIAL DRIVE**

The building harkens back to Cambridge's days as a center for car manufacturing. The building, a Ford Motor Company Assembly plant, was built in 1913 in the first stage of decentralization of Ford production from Detroit to sites around the country. It was one of thirty plants that Henry Ford built to mass produce his Model T at the dawn of the 20th century. The Northeast branch of the

Ford Company was initially located in Boston and, following construction of a new plant on Memorial Drive, moved to Cambridge in 1914. The plant stood on a riverfront site probably in consideration of Henry Ford's decree that all his factories have access to water routes.

The assembly operations were arranged vertically in the five story building, divided longitudinally, half of which was called the "train shed" where freight cars full of parts were rolled in, then lifted by crane to a floor above to be unloaded.

Although the Ford business prospered in Cambridge, the assembly operations at 640 MD by 1926, were already too small to assemble cars and trucks, so a larger factory was built at Assembly Square in Somerville (now closed) to produce Model A's.

The Cambridge building now belongs to the Massachusetts Institute of Technology which acquired it in



1956. In the years since, it was used first by the Polaroid company, on a lease basis through the 1970s, and more recently, bustling with the active and growing biotech industry.

During the approximately 30 years Polaroid leased the building from MIT, uses varied from Dr. Land's experiments with polarizing headlights and windshields in automobiles in the early days, to Camera Division

Headquarters and manufacturing operations before the move to Norwood.

Camera Division made peel apart camera components (shutters, bellows, spreaders) in the 60's plus originating Optics manufacturing which grew into a major components business supplying taking and viewing optics for all Polaroid cameras.

Additionally, the original coating line for the Sesame color transparency film was built and operated at 640MD prior to the production coater being constructed and operated in Norwood in building N2.

Polaroid also occupied two other buildings on the site, 38 Henry Street at the rear of the 640 MD parking lot where Optical Engineering was located for years, and, portions of 620 MD next door when 640 MD capacity was pushed beyond its limits.

Polaroid moved out of 640 MD in 1979 after building N4 opened in Norwood.




