

#### President's Letter

#### The Business of the PRA

The Annual May Luncheon is the Polaroid Retirees Association Board of Directors' forum for sharing the fiscal year's business information with the larger membership.

Below Is a summary of the presentations.

#### Secretary's Report: Donald Foster, Secretary

The PRA Board of Directors met fourteen times during 2023, once/month & special planning. The Governance Commission met seventeen times in 2023 to revise the PRA's Constitution, PRA survey and project progress.

#### Treasurer's Report: Bob Ruckstuhl, Acting Treasurer

Total income for the fiscal year was \$23,290. Total expenses were \$24,127, resulting in a deficit of \$655. Major expenses were for the *Newsletter* and for the Fall Luncheon.

#### Audit Committee Report: Dan Cence, Audit Committee Chair

In accordance with the requirements of our Constitution, the Audit Committee, comprising Arthur Aznavorian and Dan Cence, conducted an audit in April of 2024 of the financial transactions of the Treasurer during 2023. The scope of the audit covered all deposits, operating expenses, bank account and trust interest. The audit was accomplished by taking randomly chosen entries on the deposit and expense sides of the PRA checking account and comparing them to backup documentation provided by the Treasurer. All transactions were found to be in good order; the organization is solvent as was so reported at the 2024 May Annual Meeting of the Association.

#### Membership Committee Report: Bob Ruckstuhl, Membership Chair

The year 2023 was a sobering year for the Membership of the PRA. There were resignations, non-renewals and, sadly, the passing of 28 PRA Members. In total, we lost 100 (11%) of our Fellow Membership count.

Every effort is made to contact those who choose to resign with the objective of convincing them to remain members. This effort is sometimes successful, but more often is not. There are many hundreds of former Polaroid employees out there who are not currently PRA members, and any effort by Members to recruit these individuals is deeply appreciated.

We ended 2023 with 809 members: Full Paying Members are 579; Lifetime Members are 183; Non-Paying Members (widows and widowers of former PRA members) are 47.

Nine-years ago in 2014 the population of the PRA was 1600. If the Membership continues to decline in the future as it has in the past, our Membership numbers in the early 2030s will signal the end of the PRA. We can extend this period by recruiting younger colleagues to join us.

#### **Governance Commission, Ruth Scanlan**

The Governance Commission of the PRA Board of Directors has submitted the Constitutional amendments to the BOD and the PRA Membership for a vote by PRA members at the Annual Meeting.

# Financial Health of the PRA by Bob Ruckstuhl

The Audit Committee has affirmed that the finances of the Polaroid Retirees Association are in order and that the organization is solvent. The Association closed 2023 with an operating loss of \$655. In 2023 dues receipts were \$8298 and achieved 100% of forecast. The year closed with a cash reserve of \$26,674 of which \$7,750 is held in a restricted account which requires a 2/3 vote of the Board to invade the principle.

The PRA held its second Annual Meeting and Luncheon since the start of the COVID pandemic in the fall of 2019. The finances of the PRA benefited from the pandemic. On the expense side we canceled the luncheons in 2020 through 2022 along with their associated expenses while, on the revenue side, we continued to collect membership dues, all of which served to boost the cash reserve to its current high level. Our major expenses in 2023 were \$7,350 for our fall luncheon (offset in part by \$3,545 of member charges), \$5,141 for the publication and mailing of our quarterly *Newsletter*, and \$1,858 in administrative, website and membership expenses. It is our good fortune to have a partnership with the Direct Federal Credit Union (DFCU) who states that, "If it weren't for the Polaroid Corporation the Direct Federal Credit Union would have never come into existence." The DFCU paid for the full cost of our May Luncheon and Annual Meeting (\$11,290) which it has been doing since 2017.

A cash flow analysis of the PRA's finances conducted this year reveals that, at the current pace of receipts and spending, the Association will exhaust all its funds by 2027/2028. This is obviously an unacceptable situation and the Board is moving to address both the revenue and the expense side of this issue.

### PRA Board Raises Membership Dues Effective 1/1/2025

After considerable deliberation the PRA Board has decided to increase the annual membership dues by \$5 from \$15 to \$20, effective January 1, 2025. All dues paid after that date will be subject to the increase. Lifetime memberships will remain at \$150. The PRA has not raised its dues since 2015 when it raised them from \$10 to \$15.

Although the PRA is solvent with an \$18,924 reserve of unrestricted funds as of 12/31/23, we anticipate an annual operating deficit this year and in future years which will gradually consume this reserve. The reason for the operating deficit is clear. Our singular source of significant income is membership dues, and our membership dues receipts are shrinking as our membership shrinks. As I mentioned at the annual luncheon in May, our membership has shrunk from 1600 to 800 over the last nine years and all indications are that it will continue to shrink into the future. On the expense side of the ledger, our three major expenses are the *Newsletter*, the luncheons, and the website. All of these expenses have increased over the past years and will likely continue to increase into the future.

You might ask "Why institute a dues increase now with such a healthy reserve balance?" A ten-year cash flow analysis indicates that our reserve could run out in four years, or it could last for the next ten years, depending on the assumptions that we make and the costs that we reduce. Increasing dues at this time, before the membership shrinks any further, is the best way to maximize raising additional revenue. Beyond this, the Board is looking at ways of decreasing our operating expenses.

#### PRA's Fall Luncheon

Since the decline of COVID-19, the PRA has had three wonderful Luncheons. The Direct Federal Credit Union has been most generous in its support of the two Spring Annual Meetings & Luncheons. Nevertheless, living in our more open world is different. Going forward almost everything is more expensive. We realize this when we go out to dinner. Our favorite dishes, and even the tips for service cost more. The viability of our usual Fall Luncheon, like everything else, has to be discussed. We have enjoyed our full meals served by staff; an easy drive, in a central accessible location and with convenient parking. Our 2024 Spring Luncheon had all these things, but its actual total cost was \$78.50 per person.

PRA's Officers and Board of Directors (BOD) are looking for help in designing a different <u>Fall Gathering</u> that costs much, much less while keeping its essential face-to-face experience with lunch. The goal is \$35.

One of the things that happened in COVID was the revolution in *take-out food*. Restaurants were forced to serve their meals via Uber, instead of on their restaurant tables.

- Can we cut the cost of the meal in half by changing the menu?
- Can we find excellent delivered take-out food?
- If we can find a Community Center (American Legion, VFW, Knights of Columbus, etc.) we can avoid a ballroom's overhead expenses.

As well, the BOD is studying less-expensive restaurants with the same \$35 goal.

The BOD believes that the most essential part of our luncheons is seeing old friends and meeting new Polaroid colleagues. We need to redefine both menu and venue. We need to invent a new menu, and find a Community Center near Waltham, so our <u>Fall Gathering</u> will be affordably priced, and sustainable. We hope to have a Gathering in the last two weeks of October. All suggestions about a possible venue and a menu are appreciated!

The BOD has decided to create a New Fall Gathering! They will post their progress on <polaroidretirees.org>

# The Seven First by George Stebbins

February 10<sup>th</sup> just flew past once again! Tempus fugit! The tenth is a significant day for me personally. I began a thirty-year Polaroid career on that date in 1969.

I resigned a very interesting position in electronic equipment repair with the Massachusetts Air National Guard at Logan airport, following a number of other ANG members to Polaroid... the promised land of employment. My new career began at 28 Osborn Street in Building Trades, working for **Jim Overby** in the Instrumentation shop. Jim was an affable gentleman with a southern accent, which just enhanced his likeability. He made the Instrumentation shop a great place to start.

Of course, there was little instrumentation work at 28 Osborn itself. My new endeavors included frequent trips to most of the Cambridge sites from Windsor Street to Ames Street and further to 640 and 784 Memorial Drive. The diversity of the assignments helped make my new career not only interesting but extremely educational. The instruments we serviced varied from electrical and electronic machine controls to precise pneumatic controls and recorders intended to track some of the intricate Polaroid processes. Many of the locations required a rotating work schedule from A shift to B and sometimes C shift... whatever it took to keep the research, production and manufacturing processes running. These early seventies years at Polaroid were very exciting!

Most days I reported to 28 Osborn and received an assignment for one of the other locations. One of my first days on the job was highlighted by an event I found very humorous in nature. I was standing by the rear door of 28 Osborn after being introduced to one of the plumbers and a couple of carpenters. While we stood by the emergency exit, equipped with an alarmed crash bar, an outside salesperson approached with both arms laden with brochures, notebooks and equipment. The gentleman must have been parked behind the building near the emergency exit and was looking for a short trip to his car. He indicated the bright red crash bar and asked the plumber "Can I push that?" to which the reply was... "Sure!" Because of the armfuls of paraphernalia he backed into the bar, which created the expected cacophony of alarm bells, sirens and flashing lights, all of which caused the salesperson to immediately release his grip on the entirety of his belongings. Once the laughter subsided he looked at the plumber and asked, "I thought you said I could push that!" The response, of course, was, "You looked entirely capable to me." I decided it was going to be great working at Polaroid but I needed to be cautious how I asked questions!

# Steve Benton's Optiker Holograms at MIT Museum

**Steve Benton** worked in Research at Polaroid from 1961 to 1982 studying holography. Steve set up his holography lab in the back basement of 730 Main St. around a massive floating optical bench to reduce vibrations during long hologram exposures. In this Lab he invented the "Rainbow Hologram" in 1968. MIT President Jerome Wiesner invited Steve to be a Founding Professor of MIT's Media Lab. <a href="https://en.wikipedia.org/wiki/Stephen Benton">https://en.wikipedia.org/wiki/Stephen Benton</a>

The MIT Museum presents *Optiker*, a hologram exhibit from **June 28, 2024 - July 2025**. It has six of Steve's groundbreaking holograms donated to MIT by **Jeanne Benton**, who worked in Vision Research at 2 Osborn Street.

This is a significant selection of key experimental holograms created by Benton and his collaborators between 1968 and 1978. Stephen Benton called himself an "optiker" – someone who works at the intersection of light and vision. Benton innovated a new way to create holograms. His white-light transmission and rainbow holograms are viewable in the readily accessible light, such as a light bulb or the sun. Up to that point, most holograms required coherent laser illumination for viewing. Benton's invention injected energy into the field, opening new possibilities in imaging across scientific and commercial applications and creating a new medium for artists to explore.

# **Baker Library's Second Exhibit on Polaroid Corporation**

Baker Library Special Collections & Archives at Harvard Business School will present a second exhibit focused on the Polaroid Corporation, following 2017's *At the Intersection of Science & Art: Edwin H. Land and the Polaroid Corporation.*"

Scheduled to open in Autumn 2024, the new exhibit will focus on Polaroid's creative and commercial successes in the development of new instant photography products from 1945 to 1969. Polaroid's culture of innovation and creativity, fostered by Edwin Land and embraced by Polaroid's staff, will be examined via the rich resources held in Baker Library's Polaroid Corporation Collection. The fruitful working relationships between Edwin Land, consultants Ansel Adams and Clarence Kennedy, and Polaroid employees such as Meröe Morse, will be a particular emphasis of the exhibit.
